


WebEx Rollout

Rather than have all 49 chapters create 49+ new opportunities for the volunteer fair, we wanted to try a shared opportunity, and allow the volunteers to sign up for it on their own. Admittedly, we rushed it and sort of put the horse before the cart.

There were 2 types of opportunities offered at the fair. 'Place-Based' and 'Virtual'. 'Place-Based' opportunities in your area should already have an opportunity in your chapter. Bert Stipelcovtch from Coastal Prairie has joined the team and has some really big shoes to fill.


